2. **M/s Lanco Anpara Power Limited hereby invites bids for supply of 1.5 Lacs MT  $\pm$ 5% of Indigenous Non-Coking Coal on plant delivered basis (From January 2023 to March 2023).**
3. The Scope of work includes supply of coal through **Indian Railway Wagons [BOBRN Wagons Only]** and the successful bidder shall have to carry out handling of coal cargo till the final delivery at the Power **Station of LANPL through IR rakes** located at Village Anpara, Sonbhadra District, Uttar Pradesh located at Sonbhadra District, Uttar Pradesh, India. The power station has its own Railway Siding with Alpha-Numeric Code (LAKS – 10109142) where rakes will be unloaded the coal supplied through Indian Railway Wagons. Unloading of Coal at Power Station end from Railway Wagons shall be arranged by LANPL. The detailed terms & conditions are provided in the **Exhibit-5** enclosed herewith.
4. The prospective bidders shall submit their Techno – Commercial offer, in line with the provision of the bidding documents.

**9. Quantity Determination:**

Quantity of indigenous coal shall be determined at the Plant. The Indigenous Coal delivered shall be weighed at the Weighbridge at Plant and the weight recorded shall be taken as final. In case Plant weighbridge is out of order, Railway Receipt (RR) shall be deemed final for final reconciliation purpose. The coal will be weighed Rake wise at Plant weighbridge for the determination of quantity.

It will be the responsibility of the supplier to inform LANPL about the Rake arrival time at Plant in advance.

LANPL shall arrange the calibration at Plant weighbridge if required.

In the eventuality of weight at the Plant weighbridge being more than the RR quantity (considering the entire order quantity), the final payment shall be restricted to the RR quantity. It will be the responsibility of the Supplier to inform the Rake arrival time at Anpara 'C' TPS in advance in the prescribed format as per Annexure I.

**10. Quality Determination:**

Samples shall be drawn in accordance with the procedure laid down in IS:436 (Part I / Sec 1) - 1964, and any amendment thereof from time to time, of Indian Standard for METHOD FOR SAMPLING OF COAL AND COKE).

Similarly, analysis will be as per IS:1350 (Part-I) – 1984 Proximate Analysis at LANPL Lab. **Analysis at LANPL lab shall be final and binding.**

Sampling shall be carried out in presence of your representative if available at the time of sampling.

**11. Quality Penalty:**

**a) Deviation in GCV:**

The coal received should have a minimum GCV [ARB] of 4,001 kcal/kg as per Lanco Anpara 'C' Laboratory measurement.

**b) Deviation in Total Moisture (ARB):**

The Total Moisture in Coal should not be more than as specified in Exhibit 1: 'Indigenous Non-Coking Coal Specification'. In case Total Moisture is more than the 'specified moisture' on any day, the proportionate weight loss due to higher moisture will be reduced from the day-wise receipt quantity and the same shall be calculated with the following formula:-

**Receipt Weight = ((100-Actual TM (ARB) %) ÷ (100- 'specified moisture')) x Quantity Received**

Quality will be calculated/reconciled on rake to rake basis.

**12. Payment and Billing Terms:**

The payment terms shall be as under:

- (i) Supplier will raise tax invoice on the basis of RR weight and Actual GCV (ARB) on rake-to-rake basis. The 'Due Date' for payment shall be the date of receipt of coal at Plant or the invoice whichever is later.
- (ii) In case of Actual GCV (ARB) is more than contracted GCV (ARB), Supplier shall raise invoice on contracted GCV (ARB) only. However, no benefit of higher GCV (ARB) shall be given to the Supplier.
- (iii) The payment shall be made through Usance Letter of Credit (LC) payable after 90 days from the payment Due Date. All LC related charges payable to the LC issuing

bank including the LC opening charges etc. shall be borne by the supplier. LC shall be established on monthly Lot Basis (Lot Quantity shall be as specified in Exhibit-2) and the initial LC shall be opened in ten working days prior to start of shipment.

- (iv) 100 % of the Invoiced Value on rake-to-rake basis shall be covered by Usance LC for upto 90 days from date of bill of exchange. Usance period of entire 90 days shall be interest free. Usance interest charges shall be in supplier account.
- (v) 80 % of the Invoiced Value shall be paid on rake-to-rake basis through LC with due date as date of issuance of material receipt certificate or the invoice whichever is later.
- (vi) Balance 20% payment shall be released after monthly/final reconciliation of quantity & quality of the entire quantity to be supplied under the contract. The date of issue of reconciliation statement shall be considered as due date for such payment.
- (vii) Monthly / Final reconciliation on the basis of weight at plant weighbridge and quality as analysed through inspection will be done through LC with due date as date of issuance of reconciliation statement. However payment shall always be capped at specified GCV (ARB).
- (viii) For rakes wherein Total Moisture (ARB) is more than 12%, no payment shall be released in Tranche-A; for such rakes full payment to be released in Tranche-B after monthly / final reconciliation.
- (ix) Bills/Invoices to be submitted at LANPL, Site office by the Supplier.
- (x) The payment shall be made under Usance Letter of Credit (LC) opened under clause 8 as under:

**Tranche A:** 80% of the invoice value shall be payable upon submission of the following documents:

1. Bill of exchange for 80% of invoice value
2. Beneficiary signed retail invoice(s) for 100% of quantity shipped in one set of original plus 3 copies.

3. Coal quality analysis certificate issued by independent inspection agency certifying the GCV (ARB), Total Moisture (TM).
4. Copy of railway receipt.
5. Copy of Material receipt certificate duly certified by the Applicant's authorized signatory.
6. Transit insurance policy dated not later than the date of Railway Receipt for 110% of the invoice value.

**Tranche B:** Balance payment shall be payable on submission of the following documents:

1. Bill of exchange for adjusted value based on the monthly reconciliation and reconciliation after completion of all supplies.
  2. Original copy of Buyer's / Applicant's / LANPL's certificate showing Monthly reconciliation / Final reconciliation for quantity and quality including adjustment of penalty/dues/claim if any.
- (xi) Final Reconciliation for the entire delivered quantity will also be done at the end of the delivery of contract.

### 13. Transit Insurance:

The Supplier shall arrange and pay for a minimum inland insurance cover for 110% of the total value of coal which shall comprise of total landed cost, covering the risks under Institute Cargo Clause A including the spontaneous combustion and the risks of accidents, mishaps, war, strike, riots and civil commotion from the loading port up to the Railway Siding at Anpara 'C' TPS for coal supplied through IR Rakes. The insurance policy shall be kept valid for a period till the entire coal cargo is delivered at the coal stockyard at Anpara 'C' TPS plus a claim period of 1 (one) Month.

### 14. Other Terms:

- (i) All visible stones and shales shall be removed by the Supplier's representative at the loading point or Railway siding as the case may be and coal free from such items shall only be supplied to the plant.
- (ii) Supplier shall be responsible and bear all Charges, Government Levies, Insurance Charges etc. as incurred during the supply and transportation of our Coal from Colliery/Siding to the Plant.

- (iii) Upon issuance of the Purchase Order, Supplier shall be responsible for all the compliances pertaining to the supply of the agreed coal quantity. In case of any non-compliance, Supplier shall compensate LANPL all the liabilities arisen on it fully.

**15. Risk Purchase / Risk Sale and Limitation of Liability:**

If the Supplier fails to adhere to quality norms, delivery schedules and other terms and conditions contained in this PO for purchase of Indigenous Non-Coking Coal, LANPL shall give 7 days' notice to Supplier to rectify the breach. However, if the Supplier fails to rectify the breach within the specified period, LANPL shall have the liberty to procure the affected quantities of coal or similar coal from an alternate source at the Supplier's risk and cost, and in such eventuality if the price of such coal purchased from alternate source is more than the price of coal agreed under this PO then the Supplier shall be liable to make good the loss incurred by LANPL on account of difference in price.

**16. Compliance with Government Orders:**

Indigenous Non-Coking Coal to be supplied under this PO, is meant for the purpose of generation of power at Anpara 'C' TPS. The Supplier shall ensure compliance of all Regulations / Conventions / Policies / Guidelines / Orders etc. in force. In case of any modifications in any of the provisions in respect of supply of Indigenous Non-coking Coal, during the currency of the PO, the same shall become applicable and binding on Supplier and LANPL with immediate effect.

**17. Indemnification:**

Notwithstanding anything contained in this PO, Supplier shall at all times indemnify, defend and hold harmless LANPL from and against any losses, liabilities, claims, damages, costs and expenses incurred by LANPL by virtue of breach of any provisions of the order or non-fulfilment of any of the obligations contained herein by the Supplier.

**18. Force Majeure:**

If either the Supplier or LANPL, is directly or indirectly prevented from performance of its or their obligation under this PO by occurrence of events beyond its reasonable control such as arrest or restraints / restrictions by Government, Railways, War, Blockade, Revolution, Riots, Insurrection, Civil commotion, Acts of God, Plague or Epidemics, Destruction of the Material, Equipment or Facilities essential to the performance of this PO by fire or floods or other natural calamity or adverse weather conditions, then the occurrence of any of the above causes shall be considered as an Event of Force Majeure. Under such circumstances, neither party shall be responsible for such failure or delay in performing such obligations.

Upon the occurrence of Force Majeure cause or causes, the party invoking protection under this clause shall put the other party on notice without any delay and shall likewise intimate the cessation of such causes. The burden of proof to prove such occurrence of Force Majeure event shall be on the Party claiming such Force Majeure. If the force majeure is continued beyond the period of notice date of 21 days, then LANPL may communicate/confirm the further course.

**19. Confidentiality:**

Supplier shall not either during the term or after the expiration of the validity of the PO disclose any proprietary or confidential information relating to the PO without the prior written consent of either party.

**20. Arbitration:**

The Supplier and LANPL hereto agree that the PO for Indigenous Non-coking Coal supply shall be governed and construed in accordance with the prevailing Indian Law. Any difficulty in the construction of and/or dispute or difference arising out of and under this PO shall be settled by the parties hereto amicably by mutual agreement. In case no settlement/agreement is reached, the dispute / difference shall be referred to Arbitration and the provisions of Arbitration & Conciliation Act 1996 (as amended from time to time) shall apply. The award made in pursuance thereof shall be binding on the parties. The venue for Arbitration shall be Delhi, New Delhi, India. Any suit or proceedings to enforce the rights under the Agreement shall be instituted in and tried in a competent court of Law in Delhi, New Delhi, India.
