1. INTRODUCTION

1.1 MEIL Anpara Energy Limited (hereinafter referred to as 'MEILANEL') a company incorporated under the Companies Act, 1956, having its registered office at 411/9, Riverside Apartments, New Hyderabad, Lucknow-226007, Uttar Pradesh, India. MEILANEL is operating 2 x 600 MW Anpara 'C' coal based Thermal Power Station at P.O-Anpara, District Sonbhadra, (National Highway-39) Uttar Pradesh-231225.

In the process of generation of electricity at the Thermal Power Station, fly ash and bottom ash is generated as a by-product. MEILANEL intends to promote utilization of both fly and bottom ash as resource material. MEILANEL invites Expression of Interest (EOI) from interested parties for fly ash from the ash silos and pond ash (from Belwadah) free of cost on first come first served basis from 2x600 MW Anpara C TPS of MEILANEL as detailed below.

1.2 Basic information:

1.2.1 Plant capacity :2x600 MW (Unit 1&2).

1.2.2 The plant is situated at a distance of about 190 Kms from Varanasi

1.2.3 Total Ash Quantity: 30,00,000 Tons

2. Expression of Interest:

MEILANEL invites "Expression of Interest (EOI)" from interested parties for "Off-taking of fly ash from ash silo as well as from ash dyke at Anpara C and Ash Pond at Belwadah (14 KM away from MEIL Power Station), in as is and where is basis, for utilization and consumption in environment friendly manner as per the guidelines of CPCB/UPPCB. Interested parties may clearly indicate the inputs required from MEILANEL.

3. Purpose of this EoI:

Through this EoI, MEILANEL intends to supply ash generated from its power station; at free of cost to interested and capable agencies for utilization and consumptions in environment friendly manner as per guidelines of MoEF&CC/CPCB/UPPCB.

The Interested Parties shortlisted based on their "Expression of Interest (EOI)" will be considered for supply of ash free of cost from Anpara C Thermal Power Station, in as is and where is basis.

4. Role of the Interested Parties & MEILANEL

- 4.1 In order to promote utilization of fly ash as resource material; and to encourage the fly ash utilization of Anpara C Thermal Power Station; MEILANEL invites potential bulk users/Agencies for supply the fly ash to them free of cost for use in civil construction and other works etc. which has been listed by MoEF&CC in notification dated 31.12.2021. Help / concessions may be offered to the bulk users in this regard subject to assessment of their genuineness & mutual interest including long term agreement / tie ups for a period of more than one year subject to force majeure conditions such as change in policies etc.
- 4.2 Prospective users may submit their preliminary offers for lifting of fly ash from the dry ash Silo or from ash pond or ash from all these sources. **The offers should include the particulars of company with the background of operation, business where ash will be utilized, tentative plan, proposed quantity of ash to be utilized etc.** Preference will be given to agencies who will off take maximum quantity of ash with minimum required support from MEILANEL.
- 4.3 Interested party shall sign a long-term agreement with MEILANEL for utilization of Fly Ash in environment friendly manner as per the guidelines of UPPCB.
- 4.4 Interested agencies will transport the dry ash in environment friendly manner for utilization / consumption as per their requirement at their risk and cost.
- 4.5 Loading of dry fly ash will be made available by MEILANEL free of cost in as is and where is basis; from the Silo inside plant at Anpara C TPS. Interested agencies will have to arrange for loading and transportation of ash from ash Silo.
- 4.6 Similarly, Pond ash in dry form will be made available by MEILANEL, free of cost in as is and where is basis at Ash Pond. Interested agencies will have to arrange for loading and transportation of ash from ash pond.
- 4.7 Mode of packing, loading, transportation and utilization must be clearly mentioned by the interested agencies.
- 4.8 **Interested parties may clearly indicate the inputs/support required from MEILANEL.**
- 4.9 All the works of ash packing, loading, and transportation must be executed conforming to the EHS rules and regulations of CPCB/UPPCB.

5. Required Information:

- 5.1 The prospective fly ash users are required to submit particulars of the firm with the background of operation, business where ash will be utilized, tentative plan, and proposed quantity of fly ash to be utilized etc.
- 5.2 The party submitting the EOI shall be bearing all costs associated with the preparation and submission of the EOI and MEILANEL will, in no case be responsible or liable for these costs, regardless of the conduct or outcome of the assessment/evaluation process.

6. Submission of EOIs:

Interested parties are required to submit all the documents as per the attached format complete in all respects in email or with one original in hard form under the registered post or hand delivered to the address. The last date for submission of the EOI is 15.09.2024.

7. Terms and Conditions and General Guidelines:

- 7.1 Fly Ash & Pond Ash shall be issued from the designated storage area or other location as decided by EIC to the Successful Bidders (or their authorized representatives as may be agreed to in writing by the EIC), considering Operational and Safety issues.
- 7.2 Bidders shall make themselves aware of the various extant Rules, Procedures, Safety norms, Environmental and Sustainability Guidelines etc and carry out their activities in full compliance with the same.
- 7.3 No person / agency shall be allowed to lift ash without due permission from MEILANEL.
- 7.4 Agencies eligible for lifting ash shall apply for permission for the covered / closed trucks that they propose to deploy and submit the same to EIC along with specified documents like registration, license, insurance etc, who shall arrange to verify the same and issue permission as per prevailing procedure adopted at the Station.
- 7.5 Depending upon operational convenience, safety, etc. EIC can schedule or reschedule the lifting of ash by different agencies, which shall be binding upon the agencies. Agencies shall

start collecting the Ash as per their respective allocation as per the schedule intimated by the EIC.

- 7.6 Statutory / regulatory compliances shall be binding upon all the agencies and verifiable by MEILANEL.
- 7.7 Non-compliance shall attract penal actions ranging from fine to termination of contract / agreement / issue of Bottom ash as decided by EIC.
- 7.8 Transportation of Ash shall be in the Scope of the Successful Bidder(s). Road Permits, Operator / Driver Licenses, Insurance etc. for the deployed Vehicles shall be submitted at the time of start of work (and when new and / or additional vehicles are deployed) and thereafter as and when demanded by the EIC for verification. The vehicles shall be in fit condition for safe operation.
- 7.9 Successful Bidders shall submit affidavit on non-judicial stamp paper of requisite value, certifying the complete Utilization of issued ash, in adherence with the provisions of the extant Notification and other applicable statutory regulations. This affidavit, in prescribed format, shall be submitted on Half Yearly basis to the EIC.
- 7.10 In case of any liability on MEILANEL, in any manner that arises due to non-compliance of any Environmental and Transportation Norms, Rules, Guidelines and Statutory provisions by the successful Bidder or its representative / agent, during the course of execution and for future obligations (if any) by way of omission or commission, the Successful Bidder shall keep MEILANEL effectively indemnified of any such liability. An indemnity bond shall be submitted before start of lifting of Ash.
- 7.11 MEILANEL reserves its right to take appropriate action as deemed fit, in case information / details provided are found false even later.
