#### 1. INTRODUCTION

1.1. MEIL ANPARA ENERGY LIMITED (hereinafter referred to as 'MAEL') a company incorporated under the Companies Act, 1956, having its registered office at H. No. C/02/177, Sector C Pocket 2 Sushant Golf City, Lucknow, Uttar Pradesh, India, 226030. MAEL is operating 2 x 600 MW Anpara 'C' coal based Thermal Power Station at P.O-Anpara, District Sonebhadra, (National Highway-39) Uttar Pradesh-231225.

Ash is generated as a by-product in the process of generation of electricity at the Thermal Power Station. MAEL intends to promote utilization of pond ash as resource material for filling in low lying areas as per the provisions of MoEF&CC notification dated 31st December 2021. In order to facilitate this, MAEL wishes to allow off take of pond ash for filling in low lying areas to be issued "free of cost" and on "as is where is" basis from the ash pond of 2x600 MW Anpara C TPS situated at village Belwadah which is at a distance of around 14 KM from Power Station.

#### 1.2. Basic information:

- 1.2.1. Plant capacity :2x600 MW (Unit 1&2).
- 1.2.2. Target Quantity (TQ) of pond ash to be disposed 10,00,000 MT.
- 1.2.3. Target time Period: April 2025 to December 2025

1.2.4. The plant is situated at a distance of about 190 Kms from Varanasi Location: Anpara "C" Thermal Power Station Anpara, Sonebhadra, Uttar Pradesh.
Latitude – 24.2052° North
Longitude -82.7965° East

Nearest Railway Station: Krishna Shila (KRSL); 10Km from Generating Station

#### 2. Proposals:

MAEL invites "Proposals" from interested Landowners/representatives for ash filling in low lying areas. Brief scope of work includes excavation of ash from the ash pond and transportation of ash in closed Trucks/Bulker from the ash pond for disposal and filling in the UPPCBs approved low lying areas as per relevant CPCB guidelines. Low lying area is required to be identified and selected by Landowners/representatives within a distance of 75 Kms from the ash pond. Landowners/representatives shall also ensure all related NOC from Landowner, statutory clearances for filling of low-lying area with ash from UPPCB, liaison with local authorities. MAEL shall issue ash "free of cost" and on "as in where is basis". Landowners/representatives are requested to submit their proposal in the enclosed format.

#### 3. Bid Security

The bidders are required to deposit the Earnest Money (EMD) of INR 25,00,000 (Rs. Twenty-Five Lakhs only) for every 1,00,000 MT quoted by the representatives of landowners through DD only to be issued in favor of "MEIL Anpara Energy Limited", payable at Chennai.

# BIDS WITHOUT BID SECURITY SHALL BE REJECTED BY MAEL AS BEING NON-RESPONSIVE AND SHALL NOT BE OPENED.

#### 4. Performance Security

The EMD of the successful bidder shall be converted to Performance security and shall keep the Performance Security valid till the completion period of work order. EMD of unsuccessful bidder shall be returned within 30 days.

#### 5. Notes for Submission of Proposal

- 5.1. Interested Landowners/representatives shall be responsible to identify and select the low-lying areas at their discretion near to the ash pond preferably within 75 km.
- 5.2. Interested Landowners/representatives shall be responsible for getting all clearances from appropriate authorities including Pollution Control Board for filling up pond ash in the selected low-lying areas.
- 5.3. Shortlisted Landowners/representatives shall be issued an order mentioning quantity to be lifted in a specified period and amount in Rs/Ton as Excavation & Loading, Transportation and Unloading cost of ash from the ash pond and transportation of ash in closed Trucks/Bulker from the ash pond for disposal and filling in the UPPCBs approved low lying areas as per relevant CPCB guidelines.
- 5.4. Shortlisting and selection of Landowners/representatives shall be done on the basis of criteria given below
  - 5.4.1. Landowners/representatives who has requested for Nil or the least financial support from MAEL shall be given first priority and quantity committed by the party in its Proposal shall be given first preference for allotment. However, this shall be subject to the satisfaction of MAEL of credentials submitted by Landowners/representatives along with Proposal with regards to availability, readiness and statutory clearances for low lying area together with proof of daily transportation capability. Landowners/representatives to note that the primary objective of MAEL for inviting Proposal for low lying area is to meet its Environmental obligations and to that end MAEL is at liberty to distribute the TQ mentioned at 1.2.2 to multiple Landowners/representatives and the decision of MAEL in this regard shall be final and binding on all Landowners /representatives.
- 5.5. Prospective Landowners/representatives shall submit their Proposal for lifting of ash from the ash pond. The Proposal should include the particulars of Landowners /Representatives with the background of operation, business, tentative plan, proposed quantity of ash to be utilized etc. (Annexure-2)
- 5.6. Interested Landowners/representatives will transport the pond ash in an environment friendly manner for utilization / consumption as per their requirement at their risk (undertaking as per Annexure-3).
- 5.7. Landowners/representatives may note that transportation of ash shall be subject to provisions of Section (C)(4) of the MoEF& CC notification dated 31<sup>st</sup> December 2021.

- 5.8. Ash shall be transported only through closed Bulker/ Truck/ Dumper.
- 5.9. MAEL shall provide pond ash free of cost and on as is and where is basis; from the ash pond, till the available offered quantity is exhausted.
- 5.10. Mode of packing, loading, transportation and utilization must be clearly mentioned by the interested Landowners/representatives.
- 5.11. Interested Landowners/representatives may clearly indicate the support required from MAEL in Annexure-1.
- 5.12. All the works of ash excavation & loading, transportation and unloading must be executed confirming to the EHS rules and regulations of State Pollution Control Board UPPCB.
- 5.13. The Landowners/representatives submitting the proposal shall be bearing all costs associated with the preparation and submission of the proposal and MAEL will, in no case be responsible or liable for these costs, regardless of the conduct or outcome of the assessment/evaluation process.
- 5.14. In case of non-mobilization / inadequate mobilization, MAEL may, at its discretion, terminate the order and allocate such quantity to alternate Landowners/representatives/ end use avenue(s). Decision of MAEL shall be final and binding in this regard.
- 5.15. In case of any liability on MAEL, in any manner that arises due to non-compliance of any Environmental and Transportation Norms, Rules, Guidelines and Statutory provisions by the successful Landowners/representatives or its agent, during execution and for future obligations (if any) by way of omission or commission, the Successful Landowners/representatives shall keep MAEL effectively indemnified of any such liability. An indemnity bond shall be submitted before start of lifting of Ash.
- 5.16. MAEL reserves its right to take appropriate action as deemed fit, in case information/ details provided are found false even later.

#### 6. Qualification Requirements

There shall be no Technical and or Financial Criteria for Landowners.

However, representatives of Landowners shall have following technical & Financial Qualification requirements as given in following sections. Representatives of Landowners who do not satisfy the Technical Criteria and Financial Criteria shall be disqualified, and their Proposal shall be rejected. Representatives of Landowners is also required to submit all relevant forms specified in Technical Criteria and Financial Criteria along with their Proposal failing which, the Transporter shall be disqualified, and the Proposal shall be rejected.

Landowner / Representative submitting incomplete or unsigned forms shall also be disqualified and their Proposal shall stand rejected.
